RTCA PROGRAM MANAGEMENT COMMITTEE MEETING SUMMARY March 14, 2024

The RTCA Program Management Committee (PMC) convened in a hybrid format at 8:32 a.m. on March 14, 2024, with some members present at RTCA and others participating via Webex. The attendance list and action items are attached.

AGENDA ITEM 1 Welcome and Introductions

- A. Chair Hegarty welcomed the group, asked attendees to introduce themselves and to note their organization of affiliation. Proxies are noted in the attendance list.
- B. Secretary Hofmann reviewed the anti-trust statement, proprietary policy, and membership policy.

AGENDA ITEM 2 Review / Approve

- A. With a motion from Member Kauffman and seconded by Proxy Member Kenagy, the December 14, 2023 meeting summary was approved with edits. (RTCA Paper No. 004-24/PMC-2531)
- B. The following administrative Special Committee (SC) Terms of Reference (ToR) revision was presented. Approval was moved by Member Williams and seconded by Member Turner. The revision was approved.
 - SC-237 Helicopter Terrain Awareness Warning System (HTAWS) Change to Active Monitor (AM) status. Formal recognition by PMC for AM status. The approved ToR is posed on AerOpus (RTCA Paper No. 065-24/PMC-2561).

AGENDA ITEM 3

Publication Consideration / Approval

A. DO-230M – Standards for Airport Security Access Control Systems, presented by SC-224, Standards for Airport Security Access Control Systems

• Dr. Christer Wilkinson, SC-224 Co-Chair, and Dr. Jonathan Branker, SC-224 Technical Lead presented.

DO-230M provides guidance on acquiring and designing Airport Security Access Control Systems, as well as the integration, testing, system performance evaluation, and operational requirements related to such access control systems.

The standards outlined herein establish application recommendations for components, processes, methods, designs, and engineering practices in the implementation of Integrated Security Systems (ISSA) systems. In addition, the document contains significant additional material on potential extensions of such systems over and above the current regulatory requirements in line with industry practice, anticipated regulatory requirements and new technology.

The primary sections updated in this release are the credentialing, cybersecurity, and video sections. With growing interest in privacy concerns, this matter has been raised in these sections as the facilitation section.

This document contains forward-thinking references to technology, processes and guidance which continue to evolve. Where applicable, the Committee has made these references in the interest of providing a complete picture of the possible direction of a standard and/or technology.

• Approval was moved by Member Hennig and seconded by Member Williams. The PMC approved the standard, and it will be published as DO-230M.

AGENDA ITEM 4

Integration And Coordination Committee (ICC)

A. Report on ICC Assist with Request of Review of Document

• Clay Barber, ICC Chair, presented.

ICC Chair Barber reported that he and Senior Director, Rebecca Morrison, have been working on a process for the review of documents that have been out for publication for more than five years. This finalized process will be presented at the June 2024 PMC Meeting and will reflect inputs from PMC members (action).

AGENDA ITEM 5

Past Action Item Review

A. Ad Hoc on FRAC Comment Handling for Non-Members Comments

• Brett Eastham, RTCA COO, presented.

COO Eastham debriefed with a recommendation that this action be turned back to the PMC.

Commenters will follow the dissent process and engage the PMC and EUROCAE TAC to see if an outside independent reviewer is helpful. He stated that RTCA had a telecom listening session that President and CEO Carol Huegel participated in, and following the educational listening session, concluded that the long-standing comment process is effective, and the decision will remain with the PMC. The final listening session will be held March 27, whereby the decision will be communicated to the attendees.

There was a question from Member Turner requesting confirmation that there will not be any change to the current process. President and CEO Huegel confirmed there is no change.

Member Roy suggested communicating the decision on RTCA's website and RTCA accepted the suggestion as an action.

It was shared that during the listening session, RTCA and Dr. Hegarty encouraged the attendees to review the PMC artifacts and where the artifacts can be found on the RTCA website. The key message to the telecom nonmembers is that they are joining the process very late, and it would be more helpful to engage when the ToR is drafted.

Member Roy also asked that if comments are not technical, how will an independent reviewer be helpful?

President and CEO Huegel said the independent reviewer will look at all comments whether technical or not.

Member Hette Hoekema suggested including a reference to the ToR, in the version of the standard that is sent out for Final Review and Comment. If the group has been following the scope as defined in the ToR, it would be harder to challenge the content of the document because they are aligned.

The outcome of the ad hoc and PMC discussion was an ACTION to RTCA to add a description of the dissent process to the RTCA website (action).

B. Ad Hoc for Investigation for Possible Technical Pilot Advisory Support

• RTCA Senior Director, Standards and Technologies, Rebecca Morrison presented.

Senior Director Morrison thanked all those that were involved in this discussion and stated the takeaway is that all stakeholders need to be heard, the PMC should verify that all members are given equal voices, and that all stakeholders should be engaging early. Senior Director Morrison stated that there are two places where operational focus is needed: within the ToR and in the call for participation. She reminded the PMC of the Special Committee structure, stated that the Chair Reports will be modified to reflect operational focus, and provided a timeline of when the RTCA Special Committee Guidance will be updated.

Member Kauffman asked whether there were any PMC members who could provide technical pilot expertise to review the ToRs and support SCs as needed.

Proxy ALPA Member Kenagy answered that they have technical pilots and explained the ease and ability of ALPA to connect a member with an RTCA committee.

Member Madden answered that Airlines for America (A4A) also has technical pilots among its members and explained the A4A process.

Member Wright stated that the U.S. Air Force also has technical pilots and explained their process for accessing the expertise.

Participant Wes Googe discussed a long-standing technical pilot group that involves pilots from APA, ALPA, SWAPA, and more, and said the pilots don't have the privilege of attending all the meetings because they still fly. The goal was to have some type of coordination.

President and CEO Huegel thanked Participant Googe for communicating his concern and underscoring the importance of operational expertise to the development of standards and Senior Director Morrison asked that we take an ACTION to assess the effectiveness of the revised process in December 2024.

Member Kauffman asked if this process will be workable, and Participant Googe responded he doesn't anticipate problems with the new proposed process. Rather, the new process will be a conduit to access information for the SC documents.

Member Mendonca asked if academia or professors could be included as part of the process as well, to which it was answered yes.

Member Roy stated that he fully supports this endeavor and agrees that there is definitely a need for operational expertise in the development of technical standards. He asked if the last bullet (on the slide) is being looked at to include operational input when addressing a balance for incorporating SME engagement in technical standards.

Senior Director Morrison answered that it is being looked at and that we all have to work to find the right balance to solicit and incorporate operational input to participate in the development of technical standards.

C. SC-242/WG-124 Consider Document Name Change

• Clay Barber, SC-242 Secretary, presented.

Secretary Barber stated that this was an action from the September 2023 PMC and Member Hoekema said there might be potential confusion with the guidance document title. This was addressed during the SC-242/WG-124 January Plenary. SC-242/WG-124 agreed to change the title of deliverable and changed it from "Wireless Frequency System" to "Radio Frequency System".

Approval was moved by Member Roy and seconded by Member Kauffman. The PMC approved

the ToR and the action was closed.

D. Rewording for Proposed SC-228 Revised ToR

• RTCA SC-228 Program Director, Brandi Teel, presented.

The action was accomplished, and the revised version was sent to PMC members for Out of Cycle approval on February 5, 2024. The ballot was approved on February 18, 2024. (agenda item 6F) and the action was closed.

E. Update RTCA ToR Template to include Report Handling

• RTCA Senior Director, Standards and Technologies, Rebecca Morrison presented.

Senior Director Morrison stated that in the revised ToR template, an action was taken that a deliverable needed to be named if it was a non-DO deliverable, something other than a MOPS, MASPS, or Guidance. She added a suggestion was made to amend the deliverable table to include the exact name of document and add a column of the deliverables date. Ms. Morrison invited members to let RTCA know if there are any other suggestions to amend the ToR template.

Senior Director Morrison said these changes will be reflected in the Special Committee Guidance handbook. The action remains open.

F. Investigate Possible Export Control Restrictions with respect to RTCA

• President and CEO Carol Huegel presented.

President and CEO Huegel stated that the subject was presented to the RTCA Board of Directors (BOD) in February and the Board unanimously agreed that RTCA should engage its General Counsel on the matter. RTCA will share next steps at the PMC in June 2024. Accordingly, this action is still open.

AGENDA ITEM 6 Discussion and Standing Reports

A. RTCA President's Executive Summary

• President and CEO Carol Huegel presented.

President and CEO Huegel shared what RTCA has been working on since the last PMC meeting in December 2023. She apologized to the SC members who were impacted by the snowstorms in January. RTCA will be developing an inclement weather policy which will then be distributed.

President and CEO Huegel shared that the RTCA strategic plan is under review and emphasized that RTCA is here to serve its members and the aviation industry at large. RTCA is looking to engage the new community of airspace users along with the advanced technologies the community is adopting. Ms. Huegel expressed that RTCA understands the importance of introducing standards to the new community and Helicopter Association International (HAI) is a good example of an association that re-branded its offering (HAI is now Vertical Aviation International) to strongly message they embrace the new vertical aircraft community. RTCA would like to embrace the new community and communicate that standards = safety [rather than standards = slow].

She said RTCA is keenly aware of the focus on SC-239 and is receptive to feedback on how to do things more expeditiously, however it is not helpful to criticize the members' progress sans any suggestions for expediting the herculean effort that is underway.

President and CEO Huegel said her priorities are a seamless transition for RTCA members and internal team members. Ms. Huegel has been on a "listen and learn" tour whereby she is meeting with a collage of aviation industry organizations including sister SDOs.

President and CEO Huegel said that during the RTCA BOD meeting, hosted a few weeks ago by Honeywell in Phoenix, AZ, she and the Board members talked about the process of reimagining the RTCA Advisory Board. She expressed that RTCA and its members have an opportunity to capitalize on the talent of the Advisory Board and potentially positive impact on the needs of RTCA members.

She concluded with an acknowledgment that RTCA will be participating in the SDO roundtable with the FAA in the next week, and she is looking forward to the next stops on her "listen and learn" tour.

B. FAA Actions Taken on Previously Published Documents – Update

• Robert Bouza, FAA Representative, presented.

Mr. Bouza discussed the recently released Order 8000.376 on Development and Use of Voluntary Consensus Standards that was published on March 4. Bruce DeCleene will serve as FAA Standards Executive and lead the new Board whose primary objective is to have a more consistent and transparent approach to support standards development across the Agency. Mr. Bouza acknowledged the implementation will be challenging.

Member Barber said Garmin reviewed the order internally and has concerns about the FAA abstaining from Special Committee votes. He asked that they reconsider that part of the order and give committees guidance on whether they agree with a document or not.

Mr. Bouza said since this is an FAA-wide order, there would not be one succinct answer to how the FAA would give guidance in each committee on their opinion of the document. The process of voting has been an issue, the FAA counsel had issues with the voting.

C. EASA Action Status Summary – Report

• Hette Hoekema, EASA PMC Representative, presented.

Member Hoekema had no report for the meeting, but he did state that EASA will be doing a legal review of a hybrid surveillance with respect to spectrum management, starting in late May/early June.

D. Special Committees - Chair's Reports - Review

• RTCA Senior Director, Standards and Technologies, Rebecca Morrison presented.

Reports were received from SC-147, SC-186, SC-217, SC-223, SC-224, SC-230, and SC-235.

Senior Director Morrison discussed an update with SC-231, TAWS. SC-231 is currently in Active Monitor status and will hold a Plenary in April to decide whether or not to become Active. There is a request to update DO-367, although some companies do not see the need for a revision because it is viewed as necessary for a narrow market.

E. International Coordination – Status Update

• RTCA Senior Director, Standards and Technologies, Rebecca Morrison presented.

Senior Director Morrison provided an update on RTCA international activities which was combined with item 6I, Potential New SC Work.

F. Out of Cycle Actions since last PMC Meeting – Presentation Summary

• Karan Hofmann, PMC Secretary, presented.

G. Possible Documents for Review - Status Update

• RTCA Senior Director, Standards and Technologies, Rebecca Morrison presented.

This item was covered as part of the ICC Report, in item 4A. Senior Director Morrison explained that RTCA has developed a process to review documents in accordance with a flow chart. Ms. Morrison stated that a Word version will be distributed to the PMC for review and comment and should be returned by June 1. Senior Director Morrison stated that RTCA came up with questions from the ICC in June, September, and December 2023 to help make a decision. The burn down chart to review the documents is moving slower than planned, however progress is still being made.

Proxy Member Bouza asked how RTCA is determining if the regulators are using the documents, to which Senior Director Morrison answered that RTCA is creating a profile of usage as part of the effort. Specifically, RTCA is assessing which standards are currently being used and how they had been used if not currently being used. Proxy Member Bouza then asked will the documents that are not being used go in the store, and Senior Director Morrison answered that not all documents are in the store now, but some members may reach out to RTCA to use the documents. Proxy Member Bouza remarked that while some RTCA documents may not currently be in use, they may still be used by the FAA.

Member Roy asked if all documents are going into the website store and Senior Director Morrison said no, however if someone wants a document, they can contact RTCA to get it.

H. SC-239 – Low Range Radar Altimeter – Update

• Jean Luc Robin and Seth Frick, SC-239/WG-119 Co-Chairs, presented.

The SC-239/WG-119 co-chairs provided a briefing on the new Rad-Alt MOPS the committee is working on. The SC is fully focused on the MOPS development, holding eight in-person meetings in the last ten months, in addition to weekly WG meetings. The volume of work coupled with the limited number of technical SMEs is adversely impacting the MOPS schedule. Last month, the committee kicked off the internal committee Review and Comment (RAC) process, and there is no material in review yet. This process formalizes the review process, shows what is acceptable and what is not acceptable, all of which is preparation for the FRAC process and a document that is robust as possible. The SC co-chairs also described which articles they are focusing on for the next meeting in April.

Member Turner asked a question about the order of the test procedures and testing requirements and how they are driving schedule, to which the SC co-chairs said the requirements are being done concurrently with the test procedures.

Members of the committee voiced concerns about potential slippage in the dates of completion of the document. The leadership replied that they are keenly aware of the optics, and if they think there is any risk with dates ahead of June Plenary, they will identify those risks with the new dates when they present the ToR update at the June 27 PMC meeting.

President and CEO Huegel thanked the co-chairs of SC-239/WG-119 and Senior Director Morrison for their dedication to this effort. President and CEO Huegel further stated that all suggestions for reducing the timeline are most welcome, however it is not constructive to simply assert "it's taking too long". Ms. Huegel further requested that PMC members accurately describe the magnitude of the SC-239/WG119 effort and support RTCA's process should the matter come up in their presence. She said RTCA develops standards and is not involved in the relationship between the FAA and the FCC and/or CTIA. She emphasized that RTCA is doing everything we can to put out quality standards, and is only interested in constructive feedback.

- I. Potential New Special Committee work with new EUROCAE WG-128: Airborne Electronic Hardware Design Assurance and EUROCAE WG-129: Take off Performance Monitoring
 - RTCA Senior Director, Standards and Technologies, Rebecca Morrison presented.

Senior Director Morrison said the EUROCAE Council has approved two new working groups and per our MOU asked RTCA to consider joint work on these two new topics. Senior Director Morrison presented a draft ToR for Airborne Electronic Hardware Design (or Development—an official name has not yet been decided) Assurance, two letters of support, a verbal support, and a possible Chair. For Take Off Performance Monitoring, we have received three letters of support however RTCA is in standby waiting for the go-ahead from EUROCAE. Member Turner said The Boeing Company also supports the development of SC-243/WG-128 committee. Senior Director Morrison asked the PMC to approve the kickoff meeting and the ToR will be sent to the PMC Out of Cycle (OOC) once the committee leadership has been established.

The development of the next committee, SC-244/WG-129 is on hold to ensure there is no conflict with the SAE (AS8044A) document and the creation of a new committee. Member Barber stated that Garmin reviewed the SAE document and didn't see a conflict with the scope of the new committee and the SAE document seemed more like recommendations.

AGENDA ITEM 7 – OTHER BUSINESS

A. SC-227, Standards of Navigation Performance – Revised ToR

• SC-227 Chair, Ellen McGaughy, presented.

The group asked for delivery date changes for two documents and to develop a new MOPS with a new title and DO number instead of revising the current DO-257B MOPS to DO-257C.

• Approval was moved by Member Turner and seconded by Member Barber. The approved revised ToR (RTCA Paper No. 067-24/PMC-2563) and presentation (RTCA Paper No. 034-24/PMC-2541) are posted on AerOpus.

B. RTCA Award Nominations – Consideration / Approval of Nominations

• PMC Secretary, Karan Hofmann, presented.

Secretary Hofmann showed the list of Award Nominations for 2023 documents and asked if there were any questions. Member Turner said his name was misspelled. Secretary Hofmann said it would be corrected by RTCA.

- Approval of the nominations was moved by Proxy Member Kenagy and seconded by Member Williams. The list is posted in AerOpus (RTCA Paper No. 042-24/PMC-2546).
- C. DO-292A Assessment of Radio Frequency Interference Relevant to the GNSS L5/E5A Frequency Band, presented by SC-159, Navigation Equipment Using the Global Navigation Satellite System (GNSS) Status Update
 - SC-159 Task Lead, Sai Kalyanaraman, presented.

FRAC comments for DO-292A/ED-401A are resolved and the group in Plenary approved forwarding it to the PMC, however this standard was not finalized in sufficient time to be presented at this PMC meeting. Task Lead Kalyanaraman provided a formal presentation and asked for an out of cycle approval prior to the June PMC meeting, targeting late April.

Senior Director Morrison said SC-236 was awaiting results of Ad Hoc on FRAC Comment Handling for Non-Members Comments, which was discussed and resolved in Item 5A. She stated that she will reach out to the co-chairs to give them the update regarding how the dissent process

will be invoked with non-members, who are not satisfied with proposed committee resolution to their non-concur comments.

Chair Hegarty asked the PMC if were any PMC members that would want to participate in the dissent process and Member Roy and Member Hoekema volunteered.

E. SC-214, Standards for Air Traffic Data Communication Services – Revised ToR

• SC-214 Chair, Claire Robinson, presented.

The group asked to add a change to a previously published document (DO-351B).

• Approval was moved by Member Turner and seconded by Member Madden. The approved revised ToR (RTCA Paper No. 068024/PMC-2564) and presentation (RTCA Paper No. 048-24/PMC-2550) are posted on AerOpus.

F. SC-228, Minimum Performance Standards for Uncrewed Aircraft Systems – Revised ToR

• SC-228 Co-Chair, Brandon Suarez, presented.

The SC asked to revise delivery dates of two documents (DO-366B and DO-387) in order to develop them jointly with EUROCAE WG-105. Because the RTCA process to make the document joint between RTCA and EUROCAE was not followed, the discussion was suspended and will take place at a future PMC meeting.
